Simple graphics are used to illustrate the main points with key learning points highlighted. The training finishes with a short quiz to demonstrate the employee's comprehension of the topic

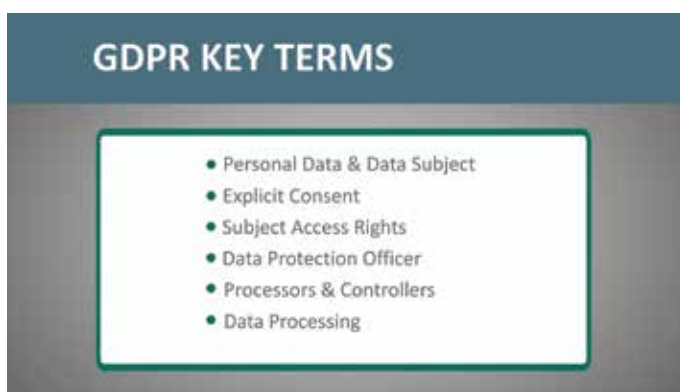


GDPR CHECKLIST

Step 1 of the ICO GDPR checklist is to ensure decision-makers and employees in your organisation are aware of the changes and the impact these will have on the organisation and daily routines.

With significant fines for non-compliance from May 2018, it is essential that your employees understand the data protection requirements under the new regulation.
